- (c) Develop and implement treatment plans and therapeutic processes.
- (d) Taking care of emergencies (on-call basis).
- (e) Work with student communities, staff and their dependents to improve psychological wellness and to address mental health issues.
- (f) Help students define goals, plan, action, and gain insight.
