1.0 NAME OF THE POST, GRADE, NUMBER OF VACANCIES, RESERVATION, PAY & EDUCATIONAL QUALIFICATION:

Note 1:

- Wherever there is no reservation for EWS/ OBC (NCL) / SC / ST Categories, candidates belonging to such categories can apply against UR vacancies.
- Qualifications which are regarded / classified as equivalent or having combination of branches other than the notified one will not be considered.
- All qualifications should have been acquired from Indian Universities/Institutes recognized by AICTE or UGC or State Board of Technical Education or NCVT or any other appropriate statutory authority in India.
- Minimum qualifying percentage of marks in the notified educational qualification is 50% (Aggregate) for UR/OBC-NCL/EWS candidates and 40% in case of SC/ST candidates against posts reserved in respect of F2-W grade posts.
- Minimum qualifying percentage of marks in the notified educational qualification is 60% (Aggregate) for UR/OBC-NCL/EWS candidates and 50% in case of SC/ST candidates against posts reserved in respect of F1-S grade posts.
- Wherever there is no reservation for SC/ST Categories, candidates belonging to such categories can apply against UR vacancies, provided relaxation for Minimum Qualifying percentage of marks does not apply to them against unreserved vacancies.

Note 2: Being Group C & D posts, Candidates applying against the vacancies notified, should have proficiency in the specified Local / Regional language i.e. Odia. In support of Local / Regional language proficiency, candidates are required to produce SSLC / 10th Standard / Matriculation Certificate as proof of having medium of study in Local / Regional language or having studied Local / Regional language as one of the subjects.

2.0 CRUCIAL DATE:

Crucial date for claim of SC/ ST/ OBC (NCL)/ EWS status or any other benefit viz. fee concession, etc., were not specified otherwise, will be the first of the month in which the Notification is issued (i.e. 01/03/2024).

* Candidates belonging to EWS/OBC(NCL)/SC/ST category can also apply against UR vacancies. However, age relaxation does not apply to them as these are unreserved posts.

4.0 PERIOD OF ENGAGEMENT:

The period of engagement is purely on Fixed Term Employment basis for a period of Three Years from the date of joining.

5.0 COMPENSATION PACKAGE AND OTHER BENEFITS:

- 5.1 Selected candidates will be paid monthly consolidated pay as mentioned at Para-1.0. In addition, the Selected candidates will be eligible for:
- 5.1.1 Provident Fund / Gratuity as per the provisions of applicable Acts / Rules.
- 5.1.2 Medical facilities as per applicable NLCIL Medical Rules.
- 5.1.3 Leave as per the Leave Rules of the Company.
- 5.1.4 Persons engaged on Fixed Term Employment who would be required to perform tours in connection with their assignments will be reimbursed TA/DA and Boarding charges as per the entitlement.
- 5.1.5 House Rent Allowance will be paid for the persons engaged on Fixed Term Employment in case they are not provided with accommodation.

6.0 RESERVATION & RELAXATION:

- 6.1 Reservation and relaxations for SC/ST/OBC (Non-creamy layer)/ EWS / PwBD (degree of disability 40% & above) & Ex-servicemen candidates will be as per Government of India guidelines.
- 6.2 SC/ST/PwBD/Ex-Servicemen Candidates are exempted from payment of application fee. However, they have to pay a non-refundable amount towards Processing Fee.
- 6.3 Candidates claim to belong to EWS / OBC (NCL) / SC/ST / PwBD/ Ex-Servicemen category should necessarily upload valid EWS / OBC (NCL) / SC/ST / Disability Certificate / Discharge Certificate, as the case may be, issued by the Competent Authority. Certificate formats can be downloaded from "Forms" tab in Careers Page of NLCIL website www.nlcindia.in.
- 6.4 Candidates belonging to OBC (NCL)/ SC/ST/EWS categories should meet the eligibility norms notified for UR category for consideration against unreserved (UR) vacancies. In other words, OBC (NCL)/SC/ST/EWS candidates applying against unreserved posts shall be considered under general standard of merit and no relaxations (except payment of application fee) shall be available for the candidates.
- 6.5 OBC Candidates belonging to "Creamy Layer" are not entitled to avail any concession otherwise extended to OBC (NCL) category. Such candidates have to indicate their category as UR.
- 6.6 Candidates belonging to OBC (Non-Creamy Layer) category should upload valid OBC (NCL) certificate in the prescribed format (applicable for purpose of reservation in appointment to posts under Government of India as contained in DOPT Memo No.36036/2/2013- Estt. (Res.) dated 30-05-2014) obtained from competent authority. However, they should produce valid OBC (NCL) certificate obtained on or after 01.04.2023 from competent authority at the time of document verification, failing which they will not be permitted for further selection/joining under OBC (NCL) Category.
- 6.7 Candidates belonging to Economically Weaker Sections (EWS) should upload valid Income & Asset certificate issued by the competent authority as per OM No.36039/1/2019-Estt (Res) dated 31.01.19 of DoPT, Ministry of PPG&P, Govt. of India. However, they should produce valid Income and Asset Certificate for Economically Weaker Sections obtained on or after 01.04.2023 from competent authority at the time of document verification, failing which they will not be permitted for further selection/joining under EWS Category.
- 6.8 PwBD candidates should possess valid disability certificate issued by a Competent Authority as prescribed vide The Rights of Persons with Disabilities Act, 2016 (RPWD Act, 2016). Such certificate shall be subject to verification/re-verification as may be decided by the Board/ competent authority.
- 6.9 Category (EWS/SC/ST/OBC(NCL)/ PwBD /Ex-servicemen) once filled in the online application form will not be changed and no benefit of other category will be admissible later on. Candidates belonging to EWS/SC/ST/OBC(NCL)/PwBD/Ex-servicemen are required to submit requisite certificate in the format prescribed by Government of India and issued by the Competent Authority.
- 6.10 Wherever there is no reservation for Persons with Benchmark Disabilities, PwBD candidates are allowed to apply as General candidates subject to the posts having been identified suitable for such disabilities. The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment have identified the jobs/posts suitable to be held by persons with benchmark disabilities and the physical requirement for all such jobs/posts vide their Gazette Notification Dt.4th January 2021. The categories of PwBD candidates who are eligible to apply for the post is given at Para-7.0

7.0 CATEGORY OF DISABILITY IDENTIFIED SUITABLE FOR THE POSTS:

Wherever there is no reservation for Persons with Benchmark Disabilities, PwBD candidates are allowed to apply as General candidates, subject to the posts having been identified suitable for such disabilities. The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment have identified the jobs/posts suitable to be held by persons with benchmark disabilities and the physical requirement for all such jobs/posts vide their Notification dated 4th January 2021.

8.0 METHOD OF SELECTION:

- 8.1 Selection will be based on Written Test for 100 marks.
- 8.2 The question paper for Written test will have 100 Multiple choice Objective Type questions carrying equal 01 mark each, with No negative marks for wrong answer.

8.3 Candidates for the post of Junior Engineer (F1-S grade) shall be evaluated in Written Test for 100 marks in the following manner:

8.4 Candidates for the post of Clerical Assistant (F2-W grade) and Industrial Worker(F2-W grade) shall be evaluated in Written Test for 100 marks in the following manner:

8.5 Duration of Written Test will be 120 minutes. The Question Paper will be in English Language only.

8.6 Minimum qualifying marks in Written Test will be 50% in respect of UR & EWS candidates and 40% in respect of SC/ST/OBC-NCL candidates, against the reserved vacancies.

8.7 Project Affected Persons (PAPs of NLCIL Project) will be allowed 20 bonus marks (limited to one beneficiary per award) in the overall marking system and minimum qualifying marks of 50% or 40% as the case may be, will be arrived after adding bonus marks.

8.8 Final selection will be in the order of merit based on the overall total score of marks obtained in written test by the candidates (plus Bonus marks awarded in case of PAP candidates), ensuring due reservation for SC / ST / OBC-NCL / EWS categories.

8.9 In case of tie at cut-off level, (i.e.) more than one candidate scoring same marks (out of 100) at cut-off level, such cases will be resolved by applying the following criteria, one after another, till the tie is resolved:

8.9.1 Date of Birth of the candidates, senior most candidate(s) by age will be placed higher;

8.9.2 Alphabetical order of first name of the candidates.

9.0 PAPS OF TALABIRA II & III OCP ELIGIBLE FOR BONUS MARKS:

PAPs falling under the following criteria will be considered as Project Affected Persons (PAPs) of Talabira II & III OCP, NLCIL for availing the benefit of 20 Bonus Marks in this engagement:

- 9.1 PAPs of lands acquired for NLCIL Talabira-II & III OCP Projects will only be considered.
- 9.2 Only one PAP/member/legal heir from a Khata/genealogy/ROR/Khatiyan will be considered even though the same PAP /member/ legal heir is having multiple Khata.
- 9.3 An applicant must be either a land owner (Pattadar / Document holder) or a legal heir of the land owner or a person(family member) nominated by the land owner for the benefit of 20 bonus marks.
- 9.4 The Land Owner can nominate any one of the family members who can be either his/her Spouse / Son / Daughter/ Son-In-Law/Daughter-in-Law / Grandson / Grand Daughter.
- 9.5 When the Land Owner is no more, one of the legal heirs of the land owner will be eligible to apply subject to the production of consent of other legal heirs.
- 9.6 If husband and wife are land owner, either of them shall be eligible.
- 9.7 If any person from Project Affected Family (PAF) is employed in NLCIL not through any LA scheme, another one member of that family will be eligible.
- 9.8 If the land owner does not have a descendant, a legally adopted Son/Daughter will be eligible subject to the production of valid documents.
- 9.9 An applicant who has purchased the property (Lands/House acquired by NLCIL) after the vesting date i.e. 05.10.2016 is not eligible for the benefit of 20 Bonus marks.
- 9.10 Settlers in Government Lands will not be eligible for Bonus marks.
- 9.11 If the Candidate's claim is based on brother/sister's award (or) any other relatives', Award, then it shall not be considered for Bonus marks.
- 9.12 Candidate who gets selected for the post under 'FTE', should not have availed and shall not avail the Cash in lieu of employment & Annuity. Candidates who have availed Annuity & Cash in lieu of employment may also be considered, if he/she is ready to return the same amount and to discontinue the annuity.
- 9.13 On Completion/Termination/Discontinuance of the term of employment, the candidate shall become eligible for availing the Annuity & Cash in lieu of employment as per the eligibility with effect from the date of completion/termination/discontinuance.
- 9.14 The eligibility of the PAPs to avail the benefit of Bonus 20 Marks in this recruitment will be solely based on the recommendations of Project Head/Talabira II & III OCP.

10.0 PROOF IN SUPPORT OF PAP TO DETERMINE ELIGIBILITY:

The candidates must attach / produce the following documents / certificates to establish the status of PAP:

- 10.1 PAP Eligibility Certificate in the prescribed format (enclosed) issued by the Project Head of Talabira II & III OCP.
- 10.2 Copy of award duly certified by the land department of Talabira Project, NLCIL and produce the original award copy at the time of verification of documents.
- 10.3 In case of land (s) / property, where the passing of award is under progress, notification for acquisition of land under CB (A&D) Act, 1957 should have been issued in respect of concerned survey number/ Khata number to become eligible to apply for the post. In this respect, the Applicants should upload copy of Khata number/Survey number duly certified by the land department of Talabira Project, NLCIL at the time of submitting application and produce the original at the time of verification of documents.
- 10.4 Land document/Patta/RoR acquired in the Talabira II & III OCP shall be produced. Unregistered documents in proof of ownership of acquired land shall not be considered for Bonus marks.
- 10.5 Residential proof (Aadhaar card/ Voter ID).
- 10.6 If the awardee is not alive, death certificate of awardee and legal heir certificate shall be uploaded [Note: In case of Legal Heir, notarized consent of all other legal heirs in favour of the applicant for availing the benefit of Bonus marks to be uploaded (format enclosed)].

10.7 If the awardee is alive, notarized consent of Awardee & family members in favour of the applicant for availing the benefit of Bonus marks to be uploaded (format enclosed).

11.0 MEDICAL FITNESS: -

Every provisionally selected candidate, prior to being appointed for the post, is required to undergo Pre-Employment Medical examination as per the prescribed health standards of NLCIL by the Company's Medical Officer and subject to being found Medically Fit, prescribed for the post.

12.0 GENERAL CONDITIONS:

- 12.1 Only Indian Nationals are eligible to apply.
- 12.2 Candidates who have passed the notified Qualifications only are eligible to apply.
- 12.3 Candidates from State PSEs / Central PSEs / Government / Quasi Government, should produce No Objection Certificate (NOC) at the time of Selection (Written Test)/Document Verification.
- 12.4 Depending upon the response and requirement, NLCIL reserves the right to raise / relax the eligibility conditions.
- 12.5 NLCIL reserves the right not to fill up any or all the posts notified at its discretion and vacancies may also be increased / decreased depending upon organizational requirements.
- 12.6 Candidates are informed that mere submission of applications shall not give them any right to be called for Selection (Written Test).
- 12.7 Candidates called for Selection (Written Test) are required to make their own arrangements for their travel, they will not be entitled for any reimbursement or Traveling Allowances.
- 12.8 Candidates will be called for selection based on Self certified information along with copies of testimonials uploaded by them. They should produce the original documents, in support of their meeting eligibility conditions, at the time of document verification failing which such candidates will not be permitted for further selection/ joining in the selected post in NLCIL.
- 12.9 Candidates already removed / terminated / deserted their employment from NLCIL or any other organisation will not be considered for engagement under FTE.
- 12.10 Candidates already resigned from NLC India Limited may also apply, subject to fulfilling the notified eligibility criteria.
- 12.11 Persons who have opted for exit under Voluntary Retirement Scheme will be considered for Fixed Term Employment in accordance with the conditions prescribed by DPE / concerned State Government guidelines.
- 12.12 NLC India Limited reserves the right to cancel/ restrict/enlarge/ modify /reopen /alter the selection process, if the need so arises, without issuing any further notice or assigning any reason thereof.
- 12.13 If the SC/ST/OBC (NCL)/ EWS/Disability certificate has been issued in a language other than English/ Hindi, the candidates should submit a self-certified translated copy of the same either in English or Hindi.
- 12.14 The company reserves the right to terminate the engagement with one-month notice or one-month consolidated compensation amount from either side without assigning any reasons.
- 12.15 The persons engaged will not be entitled to claim for any regular employment in NLCIL or any relaxations in case of any recruitment for regular posts in NLCIL.
- 12.16 Candidature of a registered applicant is liable to be rejected at any stage of selection process / Candidate's engagement will be terminated / cancelled on or after the joining, if;
 - 12.16.1 any information / documents submitted by the candidate is found to be false or
 - 12.16.2 suppressed relevant information or
 - 12.16.3 if not found to be in conformity with eligibility criteria mentioned in the advertisement.

13.0 HOW TO APPLY?

- 13.1 Candidates fulfilling all the eligibility criteria may login and apply / register online in the portal available in NLCIL website.
- 13.2 Candidates should apply only through online mode in NLC India Limited website www.nlcindia.in.
- 13.3 Before registering / applying online, the candidates should ensure that they have mobile number and valid & active personal email ID and keep them active for the entire duration of selection as NLCIL will send all selection related communications only through SMS / email till the selection process is completed.
- 13.4 Candidates have to upload required scanned copies of documents / certificates in prescribed format to establish their eligibility, failing which the application is liable for rejection.
- 13.5 Candidates applying for more than one post should apply and submit separate Registration-cum-Application Form & receipt for fee along with the requisite enclosures for each post(s).
- 13.6 Candidates should submit single application only for any post. In case of multiple applications / registrations for any post, the last registered application shall only be considered.
- 13.7 Candidates should ensure that they have uploaded the required documents before submitting application, for their benefit, after uploading a document, "View Document" option will be provided in the on-line portal to check.
- 13.8 After submitting application through ONLINE, candidate should take a print out of registration cum application form and produce it along with self-attested copies of certificates / documents, at the time of Document / Certificate verification.
- 13.9 Scrutiny of applications for short listing of candidates for Selection will be solely based on documents / certificates uploaded by the candidates at the time of registration / submission of application through ONLINE.
- 13.10 No manual / paper applications will be entertained and candidates are advised not to send any hard copy to this office.

14.2 Candidates belonging to SC/ST/PwBD & Ex-Servicemen categories are exempted from paying application fee. However, they have to pay a non-refundable amount towards processing fee.
