Terms and conditions governing the appointment of retired IT Professionals of Central/State Govt./PSU on contract basis

1. The appointment is purely on contract basis for a period of one year, with effect from the date of joining. Thereafter, the contract will lapse automatically.
2. The appointment can also be terminated at any time (on either side, at the discretion of FCI) by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority.
3. The engagement will be purely on contractual basis, initially for a period of one year with effect from the date of joining which may be extended with the approval of competent authority on the basis of satisfactory working report and conduct of the concerned.
4. The upper age limit for making application for contractual appointment will be 63 years, as of the closing date (last day of application). The contractual IT Professional will be eligible to serve FCI till he attains 65 years.
5. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any additional duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
6. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc. or any other benefits available to the Government/FCI employees, appointed on regular basis.
7. The appointee will not be granted any claim or right for regular appointment to any post.
8. Only consolidated salary will be admissible. No Dearness Allowance, increment and other allowances as are admissible to the Central Govt servants shall be admissible.
9. The appointee is not entitled to any TA for joining the appointment.
10. Other conditions of service will be governed by relevant rules and orders issued from time to time.
11. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable to removal from service and also such other action as the Government may deem necessary.
