Web Advertisement for the Post of Director of IIM Amritsar

About the Institute:

The Indian Institute of Management (IIM) Amritsar, the 15th IIM set up by the Ministry of Education, is an Institute of National Importance and a premier management education institution with a focus on excellence in research, consultancy, training, and teaching. The vision of IIM Amritsar is “Igniting Possibilities.”

Being located in Amritsar, the land of the Golden Temple and Wagah Border, the institute benefits from the enriching experience offered by this holy city. The Institute is currently run in the Punjab Institute of Technology Building. We will be moving to the permanent campus this year, which is about 30 minutes drive from the Airport/ Railway Station, making it easily accessible from all the major cities in India and Abroad.

IIM Amritsar currently offers three different MBA programs – MBA General, MBA – Business Analytics, and MBA – HRM. In addition, the institute offers Executive MBA in hybrid mode, M.Sc. in Data Science (MSDS) jointly with IIT – Ropar, Ph.D. program in Business & Management, and several long-duration Post-Graduate Certificate Programs. The institute has nearly 750 students in the various programs and has plans to unveil new programs, such as Integrated MBA, during the academic year 2025-26. The institute also has a dual degree program with Kedge Business School, France, and MoUs with other international partners. The institute has consistently climbed on the national rankings in NIRF, Outlook-Icare, India Today, Fortune, etc., and is in the top 30 in many of these rankings.

Leadership Qualities: The Director must have a history of delivering step change results and exhibiting broad-based collaboration. He/ She must be passionate and energetic, with a clear vision and hands-on humility to execute it.

Minimum Eligibility Criteria:

The applicant should have a distinguished academic record with a first-class degree in Bachelor’s and Master’s level and a Ph.D., or equivalent, from a reputed national or international institute. The applicant should have:

1. At least 15 years of teaching/ research experience, of which at least 7 years should have been as a Full Professor at IIMs or other peer institutes in India and/ or abroad.

Or

At least 15 years of industry experience in senior managerial positions in reputed organizations in India and/ or abroad.

2. Must be an Indian citizen or Overseas Citizen of India (OCI).

Appointment Terms and Conditions:

The Director shall be appointed by the Board with prior approval of the Visitor as per the terms and conditions of the IIM Act and Rules. The SCSC invites applications and nominations received from eminent persons from industry or management education. The SCSC shall have full discretion in shortlisting the applicants and conducting the process for the search for the Director. Meeting the minimum eligibility criteria does not automatically qualify the applicant for an interview.
