### 2.0 CRUCIAL DATE:

Crucial date for claim of SC/ ST/ OBC (NCL)/ EWS status or any other benefit viz. fee concession, etc., were not specified otherwise, will be the first of the month in which the Notification is issued (i.e. 01/05/2023).

## 3.0 **UPPER AGE LIMIT:**

In all the cases, the maximum age limit is 55 years as on the crucial date.

## 4.0 PERIOD OF ENGAGEMENT:

The period of engagement is purely on Fixed Term Employment basis for a period of Three Years from the date of joining.

#### 5.0 **COMPENSATION PACKAGE AND OTHER BENEFITS:**

- 5.1Selected candidates will be paid monthly consolidated pay as mentioned at Para-1.0. In addition, the Selected candidates will be eligible for:
  - 5.1.1 Provident Fund / Gratuity as per the provisions of applicable Acts / Rules.
  - 5.1.2 Medical facilities as per applicable NLCIL Medical Rules.
  - 5.1.3 Leave as per the Leave Rules of the Company.
  - 5.1.4 Persons engaged on Fixed Term Employment who would be required to perform tours in connection with their assignments will be reimbursed TA/DA and Boarding charges as per the entitlement.
- 5.1.5 Accommodation of eligible quarters will be provided to the persons engaged on Fixed Term Employment on request subject to availability. 5.1.6 House Rent Allowance will be paid for the persons engaged on Fixed Term Employment in case they are not provided with accommodation. 6.0 **RESERVATION & RELAXATION:**
- 6.1 Reservation and relaxations for SC/ST/OBC (Non-creamy layer)/ EWS / PwBD (degree of disability 40% & above) & Ex-servicemen candidates will be as per Government of India guidelines. The Reservation for PwBD is on horizontal basis.
- 6.2 SC/ST/PwBD/Ex-Servicemen Candidates are exempted from payment of application fee. However, they have to pay a non- refundable amount towards Processing Fee.
- 6.3 Candidates claim to belong to EWS / OBC (NCL) / SC/ST / PwBD/ Ex-Servicemen category should necessarily upload valid EWS / OBC (NCL) / SC/ST / Disability Certificate / Discharge Certificate, as the case may be, issued by the Competent Authority. Certificate formats can be downloaded from "Forms" tab in Careers Page of NLCIL website <a href="https://www.nlcindia.in">www.nlcindia.in</a>.
- 6.4 Candidates belonging to OBC (NCL)/ SC/ST/EWS categories should meet the eligibility norms notified for UR category for consideration against unreserved (UR) vacancies. In other words, OBC (NCL)/SC/ST/EWS candidates applying against unreserved posts shall be considered under general standard of merit and no relaxations (except payment of application fee) shall be available for the candidates.
- 6.5 OBC Candidates belonging to "Creamy Layer" are not entitled to avail any concession otherwise extended to OBC (NCL) category. Such candidates have to indicate their category as UR.
- 6.6 Candidates belonging to OBC (Non-Creamy Layer) category should upload valid OBC (NCL) certificate in the prescribed format (applicable for purpose of reservation in appointment to posts under Government of India as contained in DOPT Memo No.36036/2/2013- Estt. (Res.) dated 30-05- 2014) obtained from competent authority. However, they should produce valid OBC (NCL) certificate obtained on or after 01.04.2023 from competent authority at the time of document verification, failing which they will not be permitted for further selection/joining under OBC (NCL) Category.
- 6.7 Candidates belonging to Economically Weaker Sections (EWS) should upload valid Income & Asset certificate issued by the competent authority as per OM No.36039/1/2019-Estt (Res) dated 31.01.19 of DoPT, Ministry of PPG&P, Govt. of India. However, they should produce valid Income and Asset Certificate for Economically Weaker Sections obtained on or after 01.04.2023 from competent authority at the time of document verification, failing which they will not be permitted for further selection/joining under EWS Category.
- 6.8 PwBD candidates should possess valid disability certificate issued by a Competent Authority as prescribed vide The Rights of Persons with Disabilities Act, 2016 (RPWD Act, 2016). Such certificate shall be subject to verification/re-verification as may be decided by the Board/ competent authority.
- 6.9 Category (EWS/SC/ST/OBC(NCL)/ PwBD /Ex-servicemen) once filled in the online application form will not be changed and no benefit of other category will be admissible later on. Candidates belonging to EWS/SC/ST/OBC(NCL)/PwBD/Ex-servicemen are required to submit requisite certificate in the format prescribed by Government of India and issued by the Competent Authority.
- 6.10 Wherever there is no reservation for Persons with Benchmark Disabilities, PwBD candidates are allowed to apply as General candidates subject to the posts having been identified suitable for such disabilities. The Department of Empowerment of Persons with Disabilities, Ministry of Social Justice and Empowerment have identified the jobs/posts suitable to be held by persons with benchmark disabilities and the physical requirement for all such jobs/posts vide their Gazette Notification Dt.4th January 2021. ## 8.0 METHOD OF SELECTION:

8.1 Selection will be based on Written Test for 100 marks as below.

- 8.2 Question Paper for Written Test will be in English language and will have 100 objective type questions carrying equal 01 mark each, with no negative marks for wrong answer. Duration of Written Test will be 120 minutes.
- 8.3 Minimum qualifying marks in Written Test will be 50% in respect of UR & EWS candidates and 40% in respect of SC/OBC-NCL/PwBD candidates, against the reserved vacancies.
- 8.4 Project Affected Persons (PAPs of NLCIL Project) will be allowed 20 bonus marks (limited to one beneficiary per award) in the overall marking system and minimum qualifying marks of 50% or 40% as the case may be, will be arrived after adding bonus marks.
- 8.5 Final selection will be in the order of merit based on the overall total score of marks obtained in written test by the candidates (plus Bonus marks awarded in case of PAP candidates), ensuring due reservation for SC / ST / OBC-NCL / EWS/ PwBD categories.
- 8.6 In case of tie at cut-off level, (i.e.) more than one candidate scoring same marks (out of 100) at cut-off level, such cases will be resolved by applying the following criteria, one after another, till the tie is resolved:
  - 8.6.1 Date of Birth of the candidates, senior most candidate(s) by age will be placed higher;
  - 8.6.2 Alphabetical order of first name of the candidates.

## 9.0 MEDICAL FITNESS:

Every provisionally selected candidate, prior to being appointed for the post, is required to undergo Pre-Employment Medical examination as per the prescribed health standards of NLCIL by the Company's Medical Officer and subject to being found Medically Fit, prescribed for the post.

## 10.0 **GENERAL CONDITIONS:**

- 10.1 Only Indian Nationals are eligible to apply.
- 10.2 All qualifications should have been acquired from Indian Universities / Institutes/Board, recognized by applicable and appropriate Central/State Government authority in India.
- 10.3 Candidates who have passed the notified Qualifications only are eligible to apply.
- 10.4 Candidates from State PSEs / Central PSEs / Government / Quasi Government, should produce No Objection Certificate (NOC) at the time of Selection (Written Test)/Document Verification.
- 10.5 Depending upon the response and requirement, NLCIL reserves the right to raise / relax the eligibility conditions.
- 10.6 NLCIL reserves the right not to fill up any or all the posts notified at its discretion and vacancies may also be increased / decreased depending upon organizational requirements.
- 10.7 Candidates are informed that mere submission of applications shall not give them any right to be called for Selection (Written Test).

- 10.8 Candidates called for Selection (Written Test) are required to make their own arrangements for their travel, they will not be entitled for any reimbursement or Traveling Allowances.
- 10.9 Candidates will be called for selection based on Self certified information along with copies of testimonials uploaded by them. They should produce the original documents, in support of their meeting eligibility conditions, at the time of document verification failing which such candidates will not be permitted for further selection/joining in the selected post in NLCIL.
- 10.10 Candidates already removed / terminated / deserted their employment from NLCIL or any other organisation will not be considered for engagement under FTE.
- 10.11 Candidates already resigned from NLC India Limited may also apply, subject to fulfilling the notified eligibility criteria.
- 10.12 Persons who have opted for exit under Voluntary Retirement Scheme will be considered for Fixed Term Employment in accordance with the conditions prescribed by DPE / concerned State Government guidelines.
