The Institute invites online application for the following position from candidates possessing excellent academic background, commitment to quality teaching and potential for carrying out outstanding research or an engineer/technologist of repute from industry or R&D laboratories for the Centre of Excellence in Safety Engineering and Analytics (CoE-SEA).

**Post:** Adani Chair Professor – 1 (One) Post

**Period of appointment and duration of the Chair:** 02 years.

**Objective / Vision:**

1. Promote state-of-the art education in Safety Engineering for betterment of society;
2. Facilitate and promote research and development in Safety Engineering to provide input for design for safety;
3. Collaborate with stakeholders to enable build safe nation by working in the area of Engineering, Management Sciences and its practices with special emphasis to areas related (but not necessarily limited) to safety Engineering & Management, Reliability & Maintenance Engineering, Quality & Process Excellence, Human Factors & Ergonomics, Industrial & Systems Engineering, Data Analytics, and Virtual & Augmented Reality.

**Qualifications & Experience:**

1. As per regular Professor of the Institute as under in relevant discipline:

Ph.D. with first class or equivalent at the preceding degree in the appropriate branch with a very good academic record throughout with a minimum of 10 (ten) years teaching / research / industrial experience of which at least 4 (four) years should be at the level of Associate Professor in IITs, IISc Bangalore, IIMs, NITIE Mumbai and IISERs or at an equivalent level in any such other Indian or foreign Institution(s) of comparable standards.

**OR**

2. An eminent academician/scientist/engineer/technologist/industry expert in the relevant areas, whom the Institute feels is well-suited to meet the goals of the post.

**Emoluments:**

1. Consolidated remuneration of Rs. 2,00,000 (*Rupees Two Lakh*) per month. However, in case of retired personnel, the remuneration shall be fixed as per Government of India norms considering the pension amount, if any.

**OR**

2. A top up of Rs. 25,000 (*Rupees Twenty-Five Thousand*) per month shall be given for existing Professor of the Institute in addition to the salary drawn from the Institute.

**Residential accommodation:** The Institute shall provide unfurnished accommodation subject to availability. license fee, water charges, electricity charges and charges for any other services rendered shall be recovered as per statutes and rules framed thereunder.


**Medical facility:** OPD medical facility for self and dependent family members at B.C. Roy Technology Hospital, IIT Kharagpur.

**Role of the Appointee:** The appointee is expected to provide leadership in conducting, collaborating and coordinating practice based research & development, teaching and supervising students with the objective as mentioned above etc. to suitably meet the objectives of the Chair. Any outcome of the research performed by the appointee in the form of patents/copyrights or any other form of intellectual property will be a property of the Institute and governed by Institute rules. The appointee will submit a six-monthly report of the work carried out which will be submitted to the Institute and Adani Foundation supporting this noble cause of safety education. If the term of the appointee ends in the middle of any year, then a report will be submitted on completion of the tenure.
