VACANCY NOTICE NO. 22/2024

RE-ENGAGEMENT OF RETIRED GOVERNMENT/PSU OFFICIALS IN RLDA

Rail Land Development Authority (RLDA) is a Statutory Authority under Ministry of Railways, set up by an Amendment to the Railways Act, 1989 for development of Railway Land and Air Space for commercial use for generating revenue through non-tariff measures. RLDA is looking for Retired Railways/ Other Government/ PSU officers of various ranks for re-engagement at various locations in the country at attractive remunerations appropriate to their retired rank. The type of retired Govt/PSU officials required, the job description, tentative locations, tentative requirements and eligibility etc. are mentioned below.

Applications are invited from higher motivated Superannuated/Voluntary Retired Government/ PSUs officials from Indian Railways, Central / State Government, Development Authorities, Municipal Corporations, PSUs, Housing Boards, etc., who have worked in Civil Engineering Departments, Land Records/ Revenue Department, Architectural & Design, Train Operations, Finance matters, Establishment matters etc., having good health conditions and fulfilling requisite eligibility for their re-engagement in RLDA. Initially the re-engagement will be for a period of Two years, further extendable on need & performance basis, subject to maximum of 65 year of age. Details of requirements are as under:

1. Nomenclature of the position: Pay Levels:- 13/12/11/10/09/08/07/06/05 for Traffic/S&T/Electrical/Civil/Fin/Estt and others department.

2. Tentative Location and number of position: Total-16

Delhi-05, Secunderabad-02, Chandigarh-02, Ahmedabad-03, Muzaffarpur-01, Nagpur-02, LKO-01

The projects of RLDA is Pan India therefore the number of positions and/or indicated locations may vary as per requirement.

3. Age:

(i) Below 65 years

(ii) Cut-off date of eligibility (except the condition of retirement), shall be the closing date of a particular vacancy notice;

(iii) Maximum age for application as on closing date of applications / should be kept as 64 years.

(iv) Those who shall be honourably retiring in the next 6 (six) months after closing date of a particular vacancy notice, may also be considered eligible, subject to the condition that they fulfil other eligibility criteria for a post as on closing date of that vacancy notice.

4. Job description: Work related to Railway stations and Colonies re-development, development of Commercial & MFC sites. Co-ordinations with Govt./ Railway officers at various levels for formulation, entrustment and approval of proposals and day to day management at construction up to completion stage. In addition, co-ordination/ interaction with Urban Local Bodies/ State Govt. in Sub-divisional and CLU/ NoC cares, Any other related work assigned by RLDA.

In addition to above. Good knowledge of respected fields and market position for valuation of land and various other items of construction is required. Preferably, the officer should be a retired Railway officer having experience in construction/ maintenance of railway stations with preferred experience. Primarily to assist in planning and re-development activities related to Railway Stations, Railway colonies and Multi-functional complexes on Railway Land and others related work for elective of projects.

Expertise, at per, in respective domain would be required for the positions other than that of Projects.

5. Eligibility criteria: Superannuated/ Voluntary retired officers of pay levels 13/12/11/10/09/08/07/06/05 from Civil Engineering/ Traffic/Accounts/ Personnel/ Electrical/S&T/Estt etc. cadre of Indian Railways or equivalent level retired officials offers from Central/State Govt/ PSUs etc.

- (i) Those retired officials, who left RLDA due to any adverse reason, will not be eligible.
- (ii) Those retired officials whose retirement is due to any adverse reason, viz. compulsory retirement due to service review/under disciplinary action, removal, dismissal etc., shall not be eligible for any post in RLDA after retirement.
- (iii) Officials superannuated/voluntary retired from Railways/ Railways' PSUs or other Railways' organization will be given preference.
- (iv) Working experience in MS-Office (Word & Excel).

Desirable: Knowledge of computer applications, Microsoft office etc.
